

Dear DOVE Friends and Supporters,

DOVE is thrilled to share our FY 2016 Annual Report. With it we send our deepest appreciation to you for your role in making 2016 an enormous success. As a whole we increased the number of individuals who utilized DOVE's direct services by more than 18% over the prior year – more people are getting help! And this is because of you!

As we entered the fiscal year, DOVE was awarded two contracts through the MA Office for Victim Assistance:

- funds to expand our Legal Advocacy Program by adding a 3rd Staff Attorney, increasing our presence in the Norfolk Probate and Family Court as well as the Quincy District Court to provide consultation and legal advice to survivors, and representation regarding a range of legal matters, and
- funds to hire an LGBQ/T (Lesbian, Gay, Bisexual, Queer, and/or Transgender)
 Outreach and Advocacy Coordinator, whose role it is to conduct community
 outreach and education regarding domestic and dating violence in LGBQ/T
 communities, and also work within DOVE to strengthen our practice to better
 serve LGBQ/T survivors.

At the end of the fiscal year DOVE had received a commitment of funding starting in FY 2017 for one additional position:

 a 4th Staff Attorney to join our Legal Advocacy Program team specifically to provide assistance with domestic violence-related Immigration issues.

All of these new positions have been filled with talented, knowledgeable, and skilled staff, and we are looking forward to sharing news of their success over the coming year.

Further, DOVE's Harvesting Hope Fundraising Gala in October 2015 was our most successful to date, emphasizing our community education and prevention efforts, particularly our work with teens. DOVE's *YouthSpeak* Healthy Relationships & Teen Dating Violence Prevention Program continues to grow into new schools – High Schools and one Middle School so far – and more and more youth and gaining knowledge and skills to be active bystanders, educators, and peer supporters. Their efforts are rippling into larger communities as they move beyond high school into college or trade school, jobs, and other communities where they are making a difference on this issue!

We know that domestic violence does not exist in a vacuum. It is based on and fueled by inequities and oppression – sexism, racism, homophobia, transphobia, ableism, ageism, etc. Like the work we do with teens, we as adults need to strengthen our own skills in having conversation across difference. We also need to know where the line is between a respectful different opinion and behaviors designed to belittle, diminish, ostracize, threaten, and foster fear and hatred. We must further strengthen our ability to constructively engage in difficult dialogues, and to confront bullying and abusive talk and behaviors. DOVE's work with individual survivors to help them feel heard, understood, and known, and to regain their confidence and personal power, happens alongside DOVE's organizational social change work. These efforts are interdependent and inextricable as we strive to promote the health and wellbeing of individuals, families, and communities.

As the calendar year winds down and we enter the season of gratitude and appreciation, we extend our heartfelt appreciation to each of you for your involvement with and support of DOVE, and we look forward to continuing to partner with you in the coming year toward our vision to see domestic violence – and other forms of oppression – ended.





Hope

DOVE staff answer over 2,500 calls annually on our 24-Hour Hotline – over 200 per month – from callers seeking information about domestic violence for themselves, or for a friend, co-worker, or loved one.

Healing

Healing in the aftermath of domestic violence is a unique path for every survivor. For some, DOVE staff work with them to help them regain their balance and sense of self following a harrowing and traumatic experience. Trauma wreaks havoc on the body and soul and can have a profound impact on one's physical health and well-being in addition to creating emotional turmoil. DOVE staff work with an empowerment approach to help survivors regain a sense of personal power and control over their lives. Further, we remind survivors that they did nothing wrong, and that the abuse is not their fault. In fact, many of their choices, decisions, and actions were made in times and circumstances of extreme distress and were the best choices they could have made in the face of violence or harm to themselves, their children, or to other loved ones. We know that survivors are the experts on their own healing, and, given time and space to process the events and experiences they have had, they will be able to recover and move forward in their lives.

Safety

DOVE's Emergency Shelter has housed over 5,000 individuals and families in our 38 years of existence. When guests arrive at the Shelter, they are shown to their room and provided a Welcome Basket ~ a laundry basket with sheets, pillows, blankets, towels and a bathrobe, toys, and books for the children. These items help them begin the process of rebuilding their lives. They then have the opportunity to rest and regroup in a safe and comfortable home. Each guest meets with an advocate to learn about the services DOVE offers and to begin to define their own goals including establishing financial accounts, maintaining or pursuing a job or their education, applying for transitional housing, and/or seeking legal assistance. DOVE staff can assist clients to enroll children in the local schools, as well as seek clinical services to support their process of healing. DOVE also seeks to partner with other community organizations to ensure that victims can get help as early as possible, before injuries or the danger they face become life-threatening.

In addition, DOVE staff serve on the Norfolk County High Risk Team convened by the Norfolk County District Attorney's Office. The Team reviews cases monthly that are brought to the table by police officers, prosecutors, probation officers, or others concerned for the victim's safety. The team works to coordinate efforts to enhance the victims' safety while holding abusers accountable.

Social Change

DOVE staff provide leadership on a variety of projects focused on changing the social conditions that allow domestic violence to persist. DOVE is also actively involved in policy advocacy work on state and national levels.

DOVE's YouthSpeak program works with groups of enthusiastic teens in partner high schools and youth programs. With a curriculum focused on prevention, the YouthSpeak Educators learn and teach their peers about healthy relationships, gender roles, respect, boundaries, and how to seek help when necessary.
